Karen F. (Lindquist) Foulk, age 87, of Grand Island, passed away on Monday, December 29, 2025 at Tiffany Square.

Karen was a stay-at-home mom while her children were small but then, alongside Shorty, became an entrepreneur when they opened NebraskaLand Video stores in Aurora and York. The couple moved to York in 1984 but returned to Grand Island after selling the stores in 2009.

They enjoyed being back in Grand Island where they could resume playing in their Pinochle and Bridge Card Clubs (50+ year clubs), seeing their friends and

spending time with family. Karen had a lifelong love for cats, crafting and gambling. She also loved being a Foster Grandparent at Lincoln Elementary school in Grand Island. Karen loved hosting friends and family every weekend at their home on the lake.

Karen moved to Good Samaritan in 2018 when Shorty got sick and then to Tiffany Square 2021 where she stayed until she passed away.

She is survived by her daughter Janis (Rob) Green, son Steve (Lynn) Foulk, daughter-in-law Christy Foulk, 11 grandchildren and 17 great grandchildren, brother, Eldon (Nancy) Lindquist, sister, Lyla (Bill) Spencer; sisters-in-law, Helen Foulk, Sondra Foulk and Alice Torpin; brother-in-law, Bert Foulk; numerous nieces, nephews, cousins and close friend, Jane Kittridge.
