



## Susan M. Koenig

September 1, 1956 - February 3, 2022

Susan M. Koenig, 65, of Grand Island passed on February 3, 2022, surrounded by her family, after a four-year battle with cancer.

Celebration of Life Services will be at 11 AM Saturday, February 19th at the First Presbyterian Church, and will also be livestreamed on the church's Facebook page. Reverend Kevin Geurink will officiate. Entombment of ashes will be in the church's columbarium. Family will greet friends at the church. All Faiths Funeral Home is entrusted with arrangements. In lieu of flowers, her family suggests memorials to First Presbyterian Church of Grand Island, the Grand Island YWCA, or CASA of the Heartland.

Susan was born to Paul F. Koenig and Barbara A. (Kämpf) Koenig on September 1st, 1956 and grew up on a farm near Lindsay, Nebraska speaking mostly Swiss German. Her childhood was filled with sisters, animals and farm chores. After spending her junior year living with family in Switzerland, she graduated from Newman Grove High School in 1974. After receiving her B.A. From Wayne State College, she attended law school at the University of Nebraska and received her J.D. degree in 1982.

Susan was admitted to the Bar in 1982 and began to practice law. She served her community as a Deputy Hall County Attorney. As interim Hall County Attorney she was the first woman to serve in that capacity. Susan found a second family when she joined the firm of Mayer, Burns, Ahlschwede; now Burns, Koenig, and Ericksen. She engaged in the general practice of law until

shortly before her death.

Susan loved being a lawyer and was a friend and mentor to three generations of lawyers. Her passion for protecting children, victims of domestic violence and other underrepresented people remained undimmed throughout her career and was recognized by several awards, including the Robert Spire award from the Nebraska State Bar Association. Susan was also a fellow of the Nebraska State Bar Foundation.

On November 26th, 1983 during a record setting blizzard, Susan married Mark Young. They are the proud parents of one daughter Elizabeth Young, who was the center of life and her proudest accomplishment.

She was an active member of First Presbyterian Church and she and her family received tremendous support from the church during her illness. Susan gave of her time and talents by serving as an active board member on numerous non-profit boards. She was a member St. Francis Hospital Board when it facilitated the decision to build the new hospital tower, where she later received excellent care. She was the kind of person who always took on the most difficult tasks at any event.

Susan was an accomplished cook and a world class baker. She especially treasured cooking and baking with Liz and her friends, especially Samantha Stump. She also enjoyed sewing, knitting, and gardening.

Susan is survived by her husband Mark Young of Grand Island; daughter Elizabeth of Alamosa, Colorado; sisters Dr. Heidi Koenig (Bill Holt) of Louisville, KY and Linda Koenig of Jerseyville, Illinois and nephews Paul (Khulan) and Sam Holt. Her memory will live on in the hearts of her friends and in the lives she touched. She was preceded in death by her parents.
